## Finance Report presented by Amanda Guruge

Amanda presented the Finance report and outlined that the budget was done on an accruals basis. The key items from the budget are sponsorship, conference

accommodation and events, and affiliation fees. An increase in accounting fees reflected the need to do two sets of reporting this year.

There is part of the budget set for scholarships and grants. Members of the Council discussed the process for applications and suggested there was need to clarify or make it less complicated. This flowed into a discussion about the financial processes and policies ALSA has in place. ALSA will look to refine its financial approvals and budget process.

#### That Council replace the existing Constitution with the proposed draft

Noting that the membership stipulated in clause 5.1. has been later confirmed by LegalVision to be inconsistent with the Corporations Act 2001, and therefore if the motion is passed, clause 1.4(b) comes into effect ("to the extent that a rule in this Constitution is inconsistent with the Act then this Constitution is taken to be amended so that it is consistent with that Act").

The documents with the constitutional changes were circulated ahead of Council – with both the clean version and a schedule of the changes. This Constitution was



worked on by LegalVision on a pro bono basis. There is one change to note from the previously circulated version.

Following notice of the motion, ALSA further consulted LegalVision, who assisted with the new Constitution, and clarified that the class of membership to include 'all Australian law students' would not be consistent with the Corporations Act.

**Margaret Cai** 

Margaret spoke about ALSA being at a crossroads this year. She noted that there are great internal improvements and mechanisms (looking at a committee restructure, potential engagement of a business consultant) for ALSA to focus on. She sees the

President's role moving forward to be focused on external and advocacy.

**Vice-President Administration** 

Claire Marron (75% acquired)

Claire spoke about ALSA's need for continuity in the Administration portfolio. She says

there need to be a reflection on the structures of ALSA and support systems in place

for Conference competitions.

William Vu (75% acquired)

Will spoke about the need for transparency and communication in the Administration

portfolio. One of his priorities would be to ensure efficient and effective handover. He

noted that Competitions, Conference and Council has grown every year but the

committee hasn't changed. He identified that capacity sharing will be an important

consideration.

**Vice-President (Finance)** 

Amanda Guruge (75% acquired)

Amanda spoke about renominating for VPF position. This year was a 'catch-up' year,

and she sees next year as being the time to effect of change. She said that she intends

to create a handover that includes accounting principles and other relevant information

for VPFs to come.

**Grame Thompson** 

Grame spoke about his experience in running businesses and working with

organisations. He stressed the importance of having good governance and policy

documents.

**Aaron Payne** 

Aaron spoke about running on two key platforms: advocacy and internal governance.

He noted that he sees the VPF position as the one he is in the best place to add value,

given his experience in financial portfolios in other NFPs and incorporated

associations.

Matt spoke about his support for Maddie's approach to the education portfolio. His interests for the role are to address: the rise of trimester systems, the new Priestly 11, and online learning.
